WHEREAS, upon the recommendation of the BOE’s Engineer, it was determined that the bid as submitted by the lowest responsible bidder meets the intent and requirements of the BOE specifications; and it was recommended that the bid to perform asbestos abatement be awarded to the lowest responsible bidder, Two Brothers Contracting, Inc. and that a Contract should be prepared by the BOE Attorney; and

WHEREAS, the Board Attorney and Business Administrator shall review and approve a Contract providing Two Brothers Contracting, Inc. to serve as asbestos abatement Contractor for the BOE; and
