NOW, THEREFORE, BE IT RESOLVED that the Board hereby accepts Northeastern's request to withdraw its bid for the Project due to the significant miscalculation in the amount of its bid; **BE IT FURTHER RESOLVED** that the Board awards the contract for the Project to Tekcon in a total contract sum of \$472,415.
